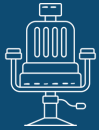

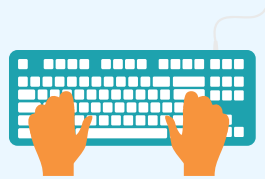

1. Open the Quote

Open the digital quote or grab the pdf quote.

We always recommend ensuring that you are logged into Foxden!



2. Click "Buy Now"

This will start the binding process!

You will have the opportunity to confirm a few details before proceeding

- Business Name
- DBA (if applicable)
- Business email
- Business phone number
- Policy start date

3. Pick Your Options

To bind a Foxquilt policy, you need to collect a signature on the application and collect payment. We help you do both!

Collecting Signature

- Choose whether you or the client will sign the application
- Foxden will send a Docusign for signature

Collecting Payment

- Foxquilt accepts all major credit cards
 1. Client Paying - you can close out Foxden here! The client will be prompted to pay after they sign the application
 2. Agent Paying - click "proceed to payment" to input the payment details



4. Get Policy Documents

Once signature and payment are successful, the policy is bound! You and the insured will be emailed policy documents, and they will be uploaded to Foxden.

Agents can issue their own certificates using an Acord 25 template.
